### MEMBERS RESIDING IN NORTH AMERICA

#### MEMBERSHIP CATEGORIES/AMOUNTS:

REGULAR MEMBERS: \$150 is now due for RSA Regular Members Dues (\$40) and subscription (\$110) to the journal *Alcoholism: Clinical and Experimental Research*.
