## STUDENT MERIT / JUNIOR INVESTIGATOR MEETING AWARDS 2010 APPLICATION INSTRUCTIONS

The Research Society on Alcoholism (RSA) will sponsor a limited number of Student Merit / Junior Investigator Meeting Awards. Awards are funded by a National Institute on Alcohol Abuse and Alcoholism (NIAAA) conference grant. The awards are intended to help defray costs associated with attendance at the 2010 RSA Scientific Meeting being held in San Antonio, TX. Awards will either cover the cost of meeting registration only or meeting registration and a minimal travel stipend.

An application (see below) must be completed by all individuals who wish to apply for a Student Merit Award (primarily intended for graduate students) or Junior Investigator Meeting Award (intended for postdoctoral fellows and trainees no more than 4 years past Ph.D. or M.D. at the time of the meeting). *Selection of awardees will be based on the merit of their abstract and stated **financial need**.* Additional consideration will be given for students and junior investigators from under-represented minority groups. Preference is also afforded to individuals who are members of RSA.

### **REQUIREMENTS:**

**STUDENT MERIT AWARD:** Graduate Student applicants must be the presenting author of an abstract accepted for presentation or a symposium speaker at the 2010 RSA Meeting. A limited number of outstanding undergraduate students may also be considered (undergraduates need not be presenting a paper, however, only one applicant per abstract will be accepted.)

**JUNIOR INVESTIGATOR MEETING AWARD:** All applicants must be the presenting author of an abstract accepted for presentation or a symposium speaker at the 2010 RSA Meeting.

**ALL APPLICANTS ARE ENCOURAGED TO ATTEND SCIENTIFIC SESSIONS  
AND WORKSHOPS ON RESEARCH SUPPORT PROGRAMS WHICH  
WILL BE OFFERED DURING THE MEETING.**

**APPLICATION PROCEDURE:** *Incomplete applications will not be reviewed.* **E-mail all requested materials (one file please) to [debbyrsa@sbcglobal.net](mailto:debbyrsa@sbcglobal.net)** or submit the original application form – with justification letter, a copy of your abstract/proposal, and a **student** verification letter from your advisor or for **post-docs**, verification that you are no more than 4 years past your degree, plus 6 (six) copies of all forms (collated and stapled) to: Research Society on Alcoholism, 7801 N. Lamar Blvd., Suite D-89, Austin, Texas 78752. **Do not fax.**

**DEADLINE:** Completed applications must be postmarked by January 8, 2010. Awards will be announced in late May.

**NOTE:** Receiving an Enoch Gordis Research Recognition Award does not preclude you from receiving an RSA Student Merit / Junior Investigator Award. You may apply for both awards.
